#### 2. Permitted Products for Resale

Suppliers are only allowed to list or resell the following categories of products:

- Tools
- Machinery
- Electronic equipment and components
- Spare parts
- Engine oil, grease, lubricants

Any listing outside of these categories may lead to removal and/or account suspension.

### 3. Payment Terms

We accept the following payment methods:

- UPI
- Net Banking
- Credit/Debit Card
- Bank Transfer
- Digital Wallets

Full payment is required at the time of order placement. We do not currently offer credit terms or pay-later options.

### 4. Order Fulfilment and Delivery

- All deliveries are handled via **Industrro's logistics partners** or **in-house delivery vehicles**.
- Suppliers are responsible for preparing the order for dispatch within **24 hours** of receiving an order.
- Once shipped, buyers will receive a tracking ID or notification.
- Industrro reserves the right to cancel or delay delivery in the case of force majeure or logistical challenges.

#### 5. Order Cancellation and Refunds

- Buyers can cancel orders **before the product is shipped**.
- Upon successful cancellation, the refund amount will be credited to the buyer's Industrro wallet.
- If a buyer initiates frequent cancellations without valid reasons, Industrro reserves the right to suspend or terminate the account.

#### 6. Return, Refund & Damage Claims

We support returns and refunds under the following conditions:

- Return requests must be made within 2 days of delivery.
- Products must be unused, in original condition and accompanied by the invoice.
- Damaged or defective products must be reported with evidence (images/video).
- Refunds for approved returns or damage claims will be processed within **3–5 business days**.
- Industrro is responsible for return shipping.

### 7. Product Listings and Quality

- All products on Industrro are listed by third-party suppliers.
- Industrro does not manufacture or stock these products.
- The **supplier** is **solely responsible** for the quality, authenticity, description and warranty of the products.
- Buyers should review supplier credentials and product specifications before purchase.

### 8. Account Suspension and Termination

Industro reserves the right to suspend or terminate user accounts without notice in the following situations:

- Fraudulent activities or false documentation
- Repeated order cancellations or return requests without valid reasons
- Violation of platform policies
- Abuse or misuse of platform features

Suspended users may not re-register without written approval.

- Product defects or warranty issues (handled by supplier)
